**1. Merit Scholarship:** The student who scored **higher points as per following weighted formula** will be selected for award of Merit Scholarship. Eligible students will get Scholarship for period of one academic year. **One student from each year shall be selected for the scholarship. Evaluation criteria as follows**

**2. Merit-cum-Need based Scholarship:** The student who scored **higher points as per following weighted formula** and income of their parents should not be more than Rs. 3,00,000/- per annum can apply for Merit-cum-Need scholarship. Eligible students will get Scholarship for period of one academic year. **One student from each year shall be selected for the scholarship. Evaluation criteria as follows**

Academic Performance	Economical Background	Extracurricular
60%	30%	10%

**3. Need-based and weaker sections Scholarship:** The student who scored **higher points as per following weighted formula** and annual income of their parents is not more than Rs. 2,00,000/- can apply for award of Need based Scholarships. Eligible students will get Scholarship for period of one academic year. **One student from each year shall be selected for the scholarship. Evaluation criteria as follows**

Academic Performance	Economical Background	Extracurricular
30%	60%	10%

Two scholarships out of the weaker sections scholarships being granted by the Institute will be reserved every year for physically handicapped students. Physically handicapped student will be as laid down by GOM. In case if physically handicapped is not available, this scholarship will be open to weaker section.

**Selection Process:** Evaluation of application will be carried out by the committee which constitute as follows

- a) Principal
- b) Head of Department
- c) Registrar
- d) Representative from Trust Office

The scholarship will be sanctioned only after the approval of Trustees.

Students having scholarship from any other source will have second priority. However exceptional cases can be considered on merit

Student must be domicile of Maharashtra

**Parents' Annual Income Limit and documents for Scholarship:** The parents' annual income limit has been fixed Rs. 2,00,000 p.a. in case of Need-based and Rs. 3,00,000 p.a. in case of Merit-cum-Need Scholarship.

**Documents require**

- 1) Income proof of father and mother (If Salaried - Form 16, IT Return,  
If Business - IT Return and P&L, Balance Sheet)
- 2) Identity Proof – PAN, Driving License, Passport, Election Voter ID Card, National Bank Pass Book,
- 3) Address Proof – Ration Card, Driving License, Passport, Election Voter ID card, National Bank Pass Book
- 4) If mother or father is not working – Self declaration that she or he is not working
- 5) If salaried and form 16 and IT Return not available - On the letter head of company with signature of competent authority
